The efficacy data, in general, should contain evidence of performance of a standard pesticide with a comparable mode of action, which has been included in the trials alongside the material under test.

¹⁰ The use of pesticides may leave residues in agro-food so residue data are for setting maximum residue limit. Residue data, if not available locally could be shared from other countries, like pre-harvest intervals. Information on the nature, concentration and fate of residues of the pesticide in foods and feeding stuffs, and proposed use directions should be included.

¹¹ Eco-toxicological properties include toxicological test results and environmental fate analysis of pesticides to be imported. in general such data can be transportable.
